***BANCA di ROMAGNA INTERNATIONAL COMPETITION  
“Generation and regeneration – Conscience and knowledge”***

1. The International Competition as above, held to mark the international congress XIII CCT – Ceramics, Cells and Tissues, Faenza – May 17-20, 2011, is aimed at artists and ceramic workers who wish to present innovative works in line with the theme of the competition.
2. The theme of the competition is “Generation and regeneration – Conscience and knowledge” and is open to anyone who successfully manages to convey the spirit of the congress and freely transfers onto a ceramic work of art the significance of the crucial moment, when the man becomes aware of his abilities and recognises them as culturally enriching.
3. The competition is open to everyone and free of charge; all entrants must send their application to the head office of Agenzia Polo Ceramico.
4. Applying to take part in the competition implies acknowledgement and acceptance of these rules, as well as authorisation to process personal data (section 13, Italian Law No. 675/96).
5. The application must be sent with the following documents:
  - a. copy of an identity document
  - b. application form duly filled out in full and signed
  - c. curriculum vitae
  - d. release form waiving all rights to claim compensation from the organisation
  - e. digital portrait photo of the entrant on CD-ROM (min. 300 dpi, 10X15 cm, .tiff format).
  - f. short technical description of the work (material, work dimensions, technique used, any additional materials used)
  - g. CD-ROM with files containing 3 (three) photos of the work taken from different angles (min. 300 dpi, 21X29.7 cm, .tiff format).
  - h. The name of the candidate must be written on the CD-ROM while the name of the work alone must appear on the files.
  - i. The work must be submitted with a compulsory written presentation of a maximum of 200 words in both Italian and English.

6. The deadline for sending applications to Agenzia Polo Ceramico, Via Granarolo 62, 48018 Faenza, Ravenna, Italy is ~~absolutely until December 31, 2010~~. **Due to the great number of enquiries, the expiry date of the Artistic Competition has been postponed to January, 31st 2011**
7. The jury will be made up of members of the congress organisation and important figures from the cultural and artistic world. The jury will examine the applications and select the candidates until March 15, 2011.
8. Artists may, at their discretion and expense, take out insurance with a company of their choice against any damages their work may incur during transportation and inside the exhibition premises for its whole duration. The insurance policy must contain a specific provision waiving all rights to claim compensation from the organisation of the international competition, which will not be liable for reimbursing any damage incurred by works for the entire duration of the event. Any artist who does not take out an insurance policy must waive all rights to claim compensation from the organisation of the international competition for any damage works may incur during transportation and the entire display period. Any works which will result damaged on their arrival at the international competition venue will not be displayed.
9. Banca di Romagna will award the winners with the following prizes:
  - a. 1st prize: Euro 2,000.00
  - b. 2nd prize: Euro 1,000.00
  - c. 3rd prize: Euro 500.00
10. The prize-winning works will remain the property of Banca di Romagna S.p.A.
11. When submitting their application, entrants are requested to state whether they wish to donate their work. Should entries be returned to their owners, the organisation will package and send them at the expense of the recipient. All additional costs, customs duties (where applicable) and sundry expenses shall be paid in full by the same recipient. Participation in the competition implies express acceptance of this condition.
